I am writing in response to your email dated 14th June 2019 requesting information under the Freedom of Information Act (2000) regarding length of stay for all male patients over the age of 80.

On the same day you replied via email with the following:

“With regards to timeframe, please can I request information for the four quarters of 2018 (or in whichever breakdown this information is available for 2018) and the first quarter of 2019, Q1 January - March?”

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Under the FOI Act 2000, please could I request your Trust’s average length of stay for all male patients over the age of 80, admitted for at least 1 night, to your Trust and discharged alive for any medical or surgical cause?

A1 As per your clarification above, please see below:


