I am writing in response to your email dated 18th July 2019 requesting information under the Freedom of Information Act (2000) regarding Trust's existing EPR.

On 22nd July 2019 we contacted you via email as UHNM had received several requests that are asking for similar information that we believe are from the same person/company, therefore as we have received no response, we are contacting you to inform you that under section 12 of the FOI Act we were aggregating these requests on Trust's existing EPR, Clinical systems and Order Communication System

The section 12 exemption states:

The authority can combine related requests received within a period of 60 consecutive days from:

- The same person or
- People who appear to be acting in concert or in pursuance of a campaign.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

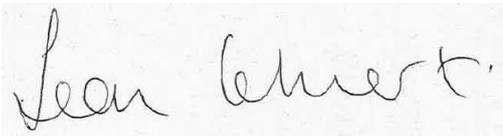
