I am writing in response to your email dated 5th January 2021 requesting information under the Freedom of Information Act (2000) regarding Covid-19

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in questions 1, 2, 5, 7 and 9 is not held centrally, but may be recorded in individual health/death records. In order to confirm whether this information is held we would therefore have to individually access all individual health/death records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all individual health/death and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority*

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just the questions that we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I would like to make a number of requests under Freedom of Information legislation, regarding the Trust.

I have the following questions, I'd be really grateful if they could be answered:

- 1. How many deaths have there been from JUST Covid 19 across the University Hospitals of the North Midlands (i.e. the Trust). These are deaths attributed just to COVID and no other health conditions.**

I am interested in figures from the 1/1/2020 until 1/1/2021 please.

A1 Section 12 exemption as detailed above. Please note: We are counting COVID-19 deaths as per the national guidance. The figure, and a description of the definition we are using, are published daily and can be found via the link below:

Q5 Of the numbers in point 4, how many were flu-like? It is my belief that Covid has been in the UK since at least October 2019, I wanted to see if the admissions reflected this

Q7 Of the people dying with Covid and other conditions, what was the most common co-morbidity?

Q8 How many staff have had to isolate due to the "track and trace" app since 1/11/2020 - 1/1/2021 as opposed to actually testing positive or having symptoms.

A8 The number of employees who reported an absence for the period 01.11.20 to 01.01.21 by answering 'yes' to the 'Test and Trace' question in the absence management system was 567

Q9 What is the number of people hospitalised for flu in:

December 2018, 2019 and 2020. Of these, how many died.

I appreciate that there is quite a list there. As stated, it is clear to me that there is a lot of anecdotal evidence to say that Covid was in the UK in Autumn of 2019. Of course you can't detect something if you don't test for it, so I am pretty sure that it would have been misdiagnosed as flu or similar.

I also believe that the track and trace app is not helping the situation on the front line. As a key worker myself I have some understanding of this.

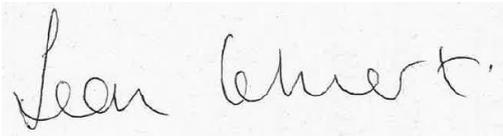
