I am writing in response to your email dated 22nd February 2021 (received into our office 23rd February) requesting information under the Freedom of Information Act (2000) regarding Chronic Renal products.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS

On 23rd February 2021 we contacted you via email as we required a timeframe in order to collate the information.

You replied the same day with:

“To clarify the item you highlighted, this refers to historical data indicating the number of treatments provided either monthly or annually.”

We responded via email with:

Thank you, however we still require timeframe, are you asking us to go back to data from last week or last year?

You replied via email with:

“My apologies – if possible for year 2020 but happy to accept a typical month if that helps?”

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

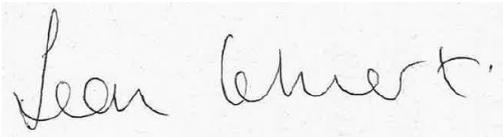
