I am writing to acknowledge receipt of your email dated 18th February 2022 requesting information under the Freedom of Information Act (2000) regarding breast cancer.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am researching the incidence and treatment of breast cancer. I would greatly appreciate if you could answer the following two questions.

How many patients have been treated for breast cancer (any stage) in the past 3 months with the following systemic anti-cancer therapies:

- Aromatase Inhibitor (e.g. anastrazole, exemestane, letrozole) as a single agent
- Abemaciclib + Aromatase Inhibitor (e.g. anastrazole, exemestane, letrozole)
- Abemaciclib + Fulvestrant
- Anthracycline (e.g. doxorubicin or epirubicin) as a single agent
- Atezolizumab +Nab-paclitaxel/Paclitaxel
- Capecitabine as a single agent

- **Carboplatin or Cisplatin as a single agent**
- **Eribulin as a single agent or in combination**
- **Everolimus + Exemestane**
- **Fulvestrant as a single agent**
- **Lapatinib**
- **Neratinib**
- **Parp Inhibitors (Olaparib/Talazoparib)**
- **Palbociclib + Aromatase Inhibitor (e.g. anastrazole, exemestane, letrozole)**
- **Palbociclib + Fulvestrant**
- **Pembrolizumab**
- **Pertuzumab + Trastuzumab + Docetaxel**
- **Ribociclib + Aromatase Inhibitor (e.g. anastrazole, exemestane, letrozole)**

- **Taxane (e.g. docetaxel, paclitaxel, nab-paclitaxel) as a single agent**
- **Trastuzumab as a single agent or in combination**

- **Any other active systemic anti-cancer therapy**

A1 We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. *Personal information*. However as the Trust is committed to openness and transparency we can band the numbers as being <5

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed. See below:

- Aromatase Inhibitor (e.g. anastrazole, exemestane, letrozole) as a single agent = 21
- Abemaciclib + Aromatase Inhibitor (e.g. anastrazole, exemestane, letrozole) = 12
- Abemaciclib + Fulvestrant = 17
- Anthracycline (e.g. doxorubicin or epirubicin) as a single agent = <5
- Atezolizumab +Nab-paclitaxel/Paclitaxel = <5
- Capecitabine as a single agent = 14
- Carboplatin or Cisplatin as a single agent = 0
- Eribulin as a single agent or in combination = 7
- Everolimus + Exemestane = <5
- Fulvestrant as a single agent = 13
- Lapatinib = 0
- Neratinib = 5
- Parp Inhibitors (Olaparib/Talazoparib) = 0
- Palbociclib + Aromatase Inhibitor (e.g. anastrazole, exemestane, letrozole) = 33
- Palbociclib + Fulvestrant = 18
- Pembrolizumab = 0
- Pertuzumab + Trastuzumab + Docetaxel = 38
- Ribociclib + Aromatase Inhibitor (e.g. anastrazole, exemestane, letrozole) = 14
- Ribociclib + Fulvestrant = <5
- Sacituzumab Govitecan = 0

- Taxane (e.g. docetaxel, paclitaxel, nab-paclitaxel) as a single agent = 15
- Trastuzumab as a single agent or in combination = 65
- Trastuzumab emtansine = 8
- Transtuzumab deruxtecan = <5
- Vinorelbine as a single agent = <5
- Any other active systemic anti-cancer therapy –
 - Epirubicin in combination = 24
 - Doxorubicin in combination = <5
 - Docetaxel in combination = <5

Please note oral medications may also be supplied in primary care. These numbers only include drugs supplied within the Trust

Q2 In the past 3 months, how many early/locally advanced (Stages I to IIIC) breast cancer patients were treated with an Aromatase Inhibitor (anastrazole, exemestane, letrozole) as a single agent?

A2 Sixteen (16) Please note oral medications may also be supplied in primary care. These numbers only include drugs supplied within the Trust


