## Dear

I am writing to acknowledge receipt of your email dated 16th June 2022 requesting information under the Freedom of Information Act (2000) regarding pronouns.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeayour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- In the Trust's written material, either external or internal, how are individuals who are pregnant referred to? E.g. As 'women', as 'pregnant people', as 'women and pregnant people' etc. Please provide this material or link(s) to it.
- We can confirm that within the guidelines and patient information leaflets, individuals who are pregnant are referred to as: "women/woman", "patient/parturient", "mother", "you/your", "ladies", "pregnant person", "pregnant woman/person" and "pregnant women/people". See attached.

- Q2 If using any wording other than solely 'women', 'women and girls' or 'females', when and why was such terminology introduced?
- A2 Some guidelines solely refer to "pregnant person", "pregnant woman/person" and "pregnant women/people" or "patient". These were first introduced in 2020. This was on the back of patient feedback which identified the necessity to update our written material to be gender neutral and inclusive
