I am writing to acknowledge receipt of your email dated 20th December 2022 requesting information under the Freedom of Information Act (2000) regarding hospital data.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Across the UK, **Construction** has over 100 retail outlets in hospitals – and we are currently working hard to improve our offering in these sites, and develop new outlets where applicable. The end goal is to tailor the offering in each of our hospital stores to suit the requirements of the prospective customer and optimise their shopping experience.

As a first step to accomplishing this, we are looking to collect a pool of data that will allows us to compare individual hospitals and build a picture of the retail setup we should look to be offering in different locations. So far, we have been able to use a combination of the KH03 and Peer Finder Tool to see Bed Availability & Occupancy, Number of Patients, Attendance, FTE Staff, % of Student Staff, etc at a Trust level.

However, the same information does not appear to be available at an individual hospital level.

As an overview, rather than at Trust level, we would like to see data for the FTE Staff, % of Student Staff, Patients & Attendances and Bed Numbers & Occupancy at an individual hospital level. Back in June, per the attached, we were advised to contact Individual Trusts directly because NHS Digital could not provide an answer to our Freedom of Information request, and we have already had a strong response from NHS Trusts during our first two rounds of FOI requests – we are now rolling out a third.

Can you please complete the attached template for all hospitals within University Hospitals of North Midlands NHS Trust, populating the yellow cells.

Please use 1 template per hospital within the trust – it is important we see the information broken down by hospital site.
