I am writing to acknowledge receipt of your email dated 20th January 2023 requesting information under the Freedom of Information Act (2000) regarding Miscarriage support

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I would like to request, under the Freedom of Information Act, the following information regarding miscarriages in maternity services.

Primary discharge reason (mother maternity services) is the primary reason that the mother was discharged from a Maternity Service.

1) The total number of cases with a Primary Discharge reason recorded and the total number of cases with a Primary Discharge reason of "Miscarriage".

Please can you provide the data with the following break downs?

- a) Yearly totals for the years 2022, 2021, 2020, 2019, 2018, 2017.
- b) Level of deprivation of the mother, from 1-Most deprived to 10-Least deprived
- c) Racial and/or Ethnic group of the mother, e.g. Asian, Black, White, etc.
- Volume of patients where Miscarriage was indicated as pregnancy outcome
 Where formal booking appointment was held excludes 'Birth' events where outcome not live
 (e.g. Unregisterable births <24wk gestation)

New maternity system implemented during 2017, therefore 2017 figures may represent partial numbers as electronic data capture of pregnancy conclusion not done prior. Unable to provide without visiting all patient notes, therefore section 12 exemption as detailed:







I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in this question is not held centrally, but may be recorded in individual health records. In order to confirm whether this information is held we would therefore have to individually access all individual health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all individual health records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: oppressive burden on the authority

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just questions 1 and 3 we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

Date based on the date Trust documented / was notified of the pregnancy outcome, which may not be the actual date of the miscarriage.
