I am writing in response to your email dated 30th January 2023 requesting information under the Freedom of Information Act (2000) regarding Telecoms and Networks.

UHNM has answered this identical request <u>eight times</u>, therefore we are only supplying any relevant updates and advise you to refer to the spread sheet we supplied 13th January 2020 on Reference 444-2021 and our detailed response on reference 146-2021 which covers any and all previous queries you may have had.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.
