I am writing to acknowledge receipt of your email dated 20<sup>th</sup> March 2023 requesting information under the Freedom of Information Act (2000) regarding our response on medicines in secondary care

## You emailed:

'Thank you for getting back to me on this. I've tried to open that link but I cannot get onto the site. Having read some of the documentation on CancerStats2 it looks like that link is for NHS personnel only so this data is unavailable to the public.

Given the above I would appreciate if my request can be reconsidered.'

We replied via email with:

Thank you for your email below, I have approached the division with your query who have responded with: we'll be able to provide the majority of the data but we do not yet have the data for the specified months. We can only provide data for Sept & Oct 22. Alternatively we can provide data for July to Oct 22 if 4 months is required. Please advise what you would like

You responded via email with:

'Thank you for looking into this. In that case the Sep & Oct 2022 date period is the most suitable for me.'

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.
