I am writing to acknowledge receipt of your email dated 1st February 2023 requesting information under the Freedom of Information Act (2000) regarding framework.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Please provide your Trust's spending on 'on-framework' recruitment agencies in 2021/22 and this financial year (2022/23); *
- A1 Totals paid to agencies are:

2021/22 £4,905,764 2022/23 £7,117,954

- Q2 Please provide your Trust's total spending on 'off-framework' recruitment agencies in 2021/22 and this financial year (2022/23);
- A2 Trust do not utilise off-framework agencies.
- Q3 Please provide a list of all the 'off-framework' recruitment agencies that your Trust uses and show how much each agency has been paid in 2021/22 and this financial year (2022/23);
- A3 We used nil off framework shifts in 2021/22 and we only used 3 Thornbury shifts in 2022/23 but I don't have the overall spend
- How many times has your Trust 'broken glass' and paid above NHS capped rates for doctors, nurses and other clinical staff in 2021/22 and this financial year (2022/23);
- I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in this question is not held centrally, but may be recorded in weekly records. In order to confirm whether this information is held we would therefore have to individually access all weekly records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12







exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all weekly records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority*

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just data that we have been submitting the NHSI Agency Return monthly (Since May 2022) we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

- A5 Three (3) shifts over one weekend in 2022/23 only
- Q6 Can you please provide the highest per hour rate paid to Thornbury Nursing Services for a shift in 2021/22 and this financial year (2022/23)? In each case, can you please detail the job category of the role provided?
 - * These are staff agencies that have been approved for use by the NHS via framework agreements, as explained in the June 2019 'Agency rules' document by NHS England and NHS Improvement.
- A6 RGN weekend shifts at £76.45 per hour
- *Please note that any individuals identified do not give consent for their personal data to be processed for the purposes of direct marketing.
