I am writing to acknowledge receipt of your email dated 2nd March 2023 requesting information under the Freedom of Information Act (2000) regarding Menopause Clinics

On the same day we contacted you via email as we required a time frame

You replied via email with the following:

'For the first three questions I would like the most recent figure that you have. Please make it clear in your response what date this figure is for.'

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am writing to submit a Freedom of Information request on the topic of menopause clinics. Please can you answer the following?

Please provide me a list of menopause clinics that the Trust operates, including the address and postcode of the clinic.

A1 See below:

Weekly Clinics held every Tuesday Royal Stoke Hospital, Newcastle Road, ST4 6QG

1 clinic once a month County Hospital, Weston Road, Stafford, ST16 3SA

2 clinic slots every other week County Hospital, Weston Road, Stafford, ST16 3SA

- Q2 What is the mean waiting time between referral and appointment at a menopause clinic within the Trust area?
- A2 See below:

Royal Stoke waiting time – 53 weeks from referral to appointment County Hospital waiting time – 52 weeks from referral to appointment







- Q3 How many people are currently on the waiting list for a menopause clinic?
- A3 There is no waiting list for new menopause appointments as patients' book directly once the referral is received at UHNM via choose and book.
- Q4 How many referrals have there been to menopause clinics each year since 2018? Please split the data by calendar year
- A4 See below:

 - 2021 442
