I am writing to acknowledge receipt of your email dated 22nd March 2023 requesting information under the Freedom of Information Act (2000) regarding nitrous oxide

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Under the Freedom of Information Act 2000, I am requesting the following information about nitrous oxide monitoring:

Have you carried out nitrous oxide/Entonox personal sampling in your Trust?

- If so, which departments have you carried out personal sampling in?
- A1 Monitoring has not been carried out since prior to the pandemic, although monitoring has been arranged with an external company to be carried out over May 3rd and 4th 2023. Personal and static monitoring has been planned to capture the levels at individual staff levels.

Once the monitoring has been completed, the findings will be communicated to the Maternity department and if any actions identified these will be implemented accordingly.

No the Trust has not suspended the use of Entonox at this time.

Q2 Did you find high results in any staff members?

If yes:

- How many staff members were affected?
- What was the highest result you found?
- Were these staff members informed?
- What action was taken? (e.g. have you installed mobile destruction units?)
- A2 Once the monitoring has been completed, the findings will be communicated to the Maternity department and if any actions identified these will be implemented accordingly.
- Q3 Have you suspended the use of Entonox at your Trust?







A3 No the Trust has not suspended the use of Entonox at this time.
