I am writing to acknowledge receipt of your email dated 12th April 2023 requesting information under the Freedom of Information Act (2000) regarding Obstetric data/Covid

You emailed:

'Many thanks for your response but the data held on the dashboard to which you refer ends in 2020 thus does not fulfil the request.'

OUR RESPONSE:

The data in the dashboards do go further than 2020, one ends December 2022 (see below) and the other March 2022 (this is a yearly dashboard so 2022/23 has not yet been released). Local figures are here: (which may differ from dashboard values due to NHSE logic etc.)

The dashboard does cover the following:

Birth volumes (Live / still / etc) - are easily available on the Monthly statistics

Unfortunately both dashboard and monthly stats do NOT cover the maternal collapses or covid 19 stats – however as a Trust this is not possible for us to report on and we'd need to visit individual records to obtain this information as it isn't captured in a way we can reliably draw analysis from+section 12 exemption as detailed below:

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in your questions is not held centrally, but may be recorded in health records. In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: oppressive
