I am writing to acknowledge receipt of your email dated 17th May 2023 requesting information under the Freedom of Information Act (2000) regarding framework

On 18th may 20230 we contacted you via email to inform you that as you had sent in two identical requests we would be aggregating them:

The section 12 exemption states:

The authority can combine related requests received within a period of 60 consecutive days from:

- The same person or
- People who appear to be acting in concert or in pursuance of a campaign.

On the same day we contacted you via email as we required clarification on what you mean by Corporate Functions departments?

You replied via email with:

'Lot 2 would be Non Clinical Temporary and Fixed Term Staff' and 'My apologies if my request has been duplicated, there is myself and Luke Jarrett working through a list of 150+ Trusts'

We responded with:

Are you asking for a structure chart for Non Clinical Temporary and Fixed Term Staff?

You replied:

'Yes please'

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am writing to you under the Freedom of Information Act 2000 to request the following information from the relevant Trust/Department. Please may you provide me with:







Confirmation if the Trust works under, Non-Clinical Temporary and Fixed Term Staff CCS Framework RM6160 and the new CCS Non-Clinical Staffing Framework Agreement RM6277.

- A1 Yes the Trust have used RM6160
- Q2 If the Trust works under, these frameworks, please can you provide a list of agencies that have supplied you with non-clinical staff and a breakdown of agency spend by bands between May 2022 and April 2023.
- A2 I can confirm that the Trust holds information regarding this request, but feel this information is exempt under section 21: *information reasonably accessible by other means*.
