## Dear

I am writing to acknowledge receipt of your email dated 7th June 2023 requesting information under the Freedom of Information Act (2000) regarding SNOMED codes

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 For the period from the 1st of March 2022 to the 28th of February 2023,
  - (a) how many patients were admitted to your hospitals with the following SNOMED codes.
  - (b) how long did they stay in the hospital in terms of the average length of stay,
  - (c) how many were readmitted within 30, 60 and 90 days, and
  - (d) how many wards were they admitted to during their stay?

A1 UHNM does not use SNOMED codes when coding inpatient activity, we use OPCS 4.10, and therefore we are unable to answer this request.

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in this question is not held centrally, but may be recorded in health records. In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: oppressive burden on the authority

How was their respiratory rate incorporated into the NEWS2 record and EHR or similar system for the patients admitted with these codes?







## Please describe as closely as possible the process and systems used.

- A2 The wards use the Trust system to record patient observations. The healthcare professional will complete the observations and input into the handheld device. –this would be inputted and recorded via VitalPac
- Q3 Was any digital or remote patient monitoring of respiratory rate used to monitor these patients? If yes, what form did this monitoring take, and who was the supplier or manufacturer?
- A3 Through a COPDPredict Virtual ward project those patients with SNOWMED 195951007 which involved the patient sending in daily response to COPD questions and spirometer and pulse oximeter readings to detect the onset of an exacerbation. The supplier of COPD Predict is NePESmo
