I am writing to acknowledge receipt of your email dated 16th June 2023 requesting information under the Freedom of Information Act (2000) regarding Breast Cancer screening and diagnosis.

On the same day we contacted you via email as we required the following clarification: *"How many patients have been screened for breast cancer within your organisation in the last 12 months?"* Can you please clarify if this is to include both the national NHS screening programme and those screening activities for patients who have symptoms?

"Over the last 12 months, how many patients has your organisation treated or screened for breast cancer with the following modalities? Mammography, Tomosynthesis, Magnetic Resonance Imaging (MRI) and Computerised Tomography (CT)". Can you please clarify what you mean by 'treated' as these listed are diagnosis and screening methods and not treatment methods?

"How many private providers offer access for potential breast cancer patients within your catchment area to the following modalities?" Can you please clarify if you are requesting how many private providers offer this service for the NHS or how many UHNM have a contract with?
