I am writing to acknowledge receipt of your email dated 5th July 2023 requesting information under the Freedom of Information Act (2000) regarding Free Standing Birthing Unit at County

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

I make the following FOI request of UHNM NHS Trust. I ask that the timelines in fully responding to my request below be adhered to. If there is a likelihood of delays in providing the information I request I be fully kept in the loop as to such.

I understand that UHNM NHS Trust has undertaken and completed a review of its facility namely the Free Standing Birthing Unit (FBU) County Hospital Stafford that has been closed since March 2020 and ownership of the aforesaid review does sit with UHNM NHS Trust.

I also further understand that this review above has informed UHNM as to its future usage or otherwise of the FBU County Hospital and that UHNM has made these intentions known.

- 1. Please provide me with the Review as per above and the reviews recommendations/conclusions.
- A1 I can confirm that the Trust holds information regarding this request, but feel this information is exempt under section 22: *Information for future publication*

In addition UHNM is applying the following exemption:
