I am writing to acknowledge receipt of your email dated 2nd May 2023 requesting information under the Freedom of Information Act (2000) regarding Patient-on-staff sexual harassment.

On the same day we contacted you via email as the FOI Act clearly states that if we suspect that the request has come from a Pseudonym we are entitled to request proof of the person's identity, as provision of a Pseudonym invalidates a request, therefore please can you provide a photo copy of your driver's licence or other official document that validates your identity.

On 3rd September 2021 we contacted you via email as you had used two entirely different names on FOI reference 300- 2122, whilst you provided proof of Identity for 'one' of your names, you omitted to provide for '

Section 8 – "Real name" checks

Can you please confirm that you are only submitting this request for your personal use or that of an unstructured group and not on behalf of a company/corporate body?

If you are making the request on behalf of a company/corporate body as an employee, then you should declare the real company name and this will enable us to consider the validity of the request.

Thank you for your honesty, UHNM is happy to work with you in order to answer FOI's however under the FOI Act we are not required to answer requests that have a Pseudonym, therefore we will answer this request under this request under this request under the following point in future we will decline any requests made under your pseudonymous account







As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Please tell me how many times your Trust has logged an incident of alleged sexual harassment from patients towards staff in 2022.
- A1 Total from Jan 2022 to Dec 2022 = 9
- Q2 For the five most recent cases, please tell me
 - a) the job title of the member of staff against whom the behaviour was levelledb) a brief summary of the content of the complaint (patient said "you can warm your hands up on me" during a physical examination, patient wolf-whistled at nurse, etc.)c) the action taken by the Trust.
- A2 See below:
 - a) Information not held as requested
 - b) The 5 most recent incidents recorded involve inappropriate sexual behaviours towards staff; some involved sexual advances other involved sexually inappropriate language.
 - c) Actions taken include discharging the person from site, verbal cautions by staff and security, behavioural charts completed, Datix's completed.
