I am writing to acknowledge receipt of your emails dated 29th June 2023 and 5th July requesting information under the Freedom of Information Act (2000) regarding A&E performance and Continuous flow

On 29th June 2023 you contacted us via email with:

'Just to give you notice that if you direct me to NHSE published data on trust level data (as one trust has already), then I will immediately request a review.

My FOI is very clear that I am requesting SITE level, NOT trust level data'.

On 5th July 2023 we contacted you via email advising you that under section 12 of the FOI Act we were aggregating these two requests

On 23rd August 2023 you contacted us via email to withdraw request #2

The authority can combine related requests received within a period of 60 consecutive days from:

(Section 12 exemption)

- The same person or
- People who appear to be acting in concert or in pursuance of a campaign.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Request #1

Q1 Under the FOIA, please could you provide the following information?

For each of your type one A&E departments, please provide site-specific data on four hours A&E performance (so xx% for A&E 1, xx% for A&E 2 etc)







For each site, please split this between a) admitted patients b) all patients (both admitted and non-admitted)

Please provide this by month from the start of 2022/23, including for 2023/24 up to 29 June 2023 (or the latest date possible). Please also provide aggregate four hours performance data for both 2022/23 and 2023/24 so far.

Please provide the data on the template provided.

Request #2

Q1 Under the FOIA, please could you provide me with the following information?

At any time in the last 12 months, has your Trust enacted a 'continuous flow' model where urgent and emergency patients are moved onto wards at regular intervals, whether or not beds were available? This is commonly referred to as the 'North Bristol' model - further details here: https://www.nuffieldtrust.org.uk/news-item/should-emergency-departments-move-patients-to-other-wards-even-when-there-s-no-bed-space-available please supply the dates in which this has been used.

- Q2 Is your Trust still using a 'continuous flow' model? If your Trust is no longer doing this, please could you detail why?

- Q4 During the time you used continuous flow, how many 12 hour delays from time of admission were reported, and what was the average bed occupancy, and inpatient length of stay? Please also provide this data for the same months of the previous year when you were not using continuous flow.

- Q5 During the time you used continuous flow, how many patient safety or serious incidents of a) overcrowding on wards b) overcrowding in A&E were reported? Please also provide this data for the same months of the previous year when you were not using continuous flow.
- A5 Request withdrawn 23rd August 2023
- Q6 During the time you used continuous flow, how many patients suffered moderate to severe harm linked with a) overcrowding on wards b) delays in the A&E department?







Again, please also provide this data for the previous year when continuous flow was not being used.
