## Dear

I am writing to acknowledge receipt of your email dated 5th September 2023 requesting information under the Freedom of Information Act (2000) regarding strikes.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I'm writing to request information from NHS trusts in England about how much was spent on locum and agency doctors during the walkouts held by both consultants and junior doctors over the past 12 months.

Please provide answers for each timeframe and separate each one clearly in your response.

These timeframes are:

- (A) Junior doctor strike 13, 14 and 15 March 2023
- (B) Junior doctor strike 11, 12, 13, 14 and 15 April
- (C) Junior doctor strike 14, 15, 16 and 17 June
- (D) Junior doctor strike 13, 14, 15, 16, 17 and 18 July
- (E) Junior doctor strike 11, 12, 13, 14 and 15 August
- (F) Consultant strike 20 and 21 July
- (G) Consultant strike 24, 25 and 26 August

For each given timeframe could you please provide the following information.

1. How many staff walked out as a result of industrial action over each period and what percentage of your junior doctor/consultant staff did this equate to. IE – 150 junior doctor staff walked out during 13, 14 and 15 March dates out of 200 junior doctor staff would be 75%.
