I am writing to acknowledge receipt of your email dated 16th November 2023 and 4th December 2023 requesting information under the Freedom of Information Act (2000) regarding MRI scans and radiation dose recording

We replied via email with the following:

UHNM has received several requests that are asking for similar information that are from the same person/company, therefore we are contacting you to inform you that under section 12 of the FOI Act we were aggregating these requests on MRI scans and radiation dose recording

Your new reference number for BOTH is 593-2324

The section 12 exemption states:

The authority can combine related requests received within a period of 60 consecutive days from:

- The same person or
- People who appear to be acting in concert or in pursuance of a campaign.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.
