I am writing to acknowledge receipt of your email dated 28th November 2023 requesting information under the Freedom of Information Act (2000) regarding Datix

On the same day we contacted you via email as in order to continue with your request we require clarification on what statistics you are referring to? All datixs?

On the same day you amended your request with further questions and the following clarification 'May I please know all medication errors reported using the risk management information system within the trust during the timeframe of October 2022-October 2023

May I also have the medication errors reported on the elderly and frailty ward within the time frame of October 2022 - October 2023'

On 15<sup>th</sup> December 2023 you submitted another request to which we responded with the following:

UHNM has received several requests that are asking for similar information that are from the same person/company, therefore we are contacting you to inform you that under section 12 of the FOI Act we were aggregating these requests Datix and whiteboard

Your new reference number for BOTH is 626-2324

The section 12 exemption states:

The authority can combine related requests received within a period of 60 consecutive days from:

- The same person or
- People who appear to be acting in concert or in pursuance of a campaign.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

# Q1 May I please know the statistics on DATIX incident numbers in the last 12 months between October 2022-October 2023 - clarified:

## May I please know all medication errors reported using the risk management information system within the trust during the timeframe of October 2022-October 2023

- A1 As per your above clarification: Total incidents reported on Datix (01/10/2022 – 31/10/2023): 33721 Total medication related incidents (01/10/2022 – 31/10/2023): 3350
- Q2 May I also have the medication errors reported on the elderly and frailty ward within the time frame of October 2022 October 2023'
- A2 Total medication incidents reported in Elderly Care (01/10/2022-31/10/2023): 134

### Request #2

# Q1 What is the data for the last 5 years concerning the top 5 wards in the trust which have the highest staff turnover rate/lowest staff retention rate, including how many staff were employed and left each year for each of those wards.

A1 I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in this question is not held centrally, but may be recorded in ESR (This is 180 reports x 8mins per report = 1,440 minutes which is 24 hours to purely run the reports, even before the analysis can be done). In order to confirm whether this information is held we would therefore have to individually access all ESR records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all ESR records and then extracting relevant information would take longer than the 18 hours allowed for. *In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: oppressive burden on the authority* 

#### Q2 What are the current costs of a whiteboard and whiteboard pen?

A2 See below: Whiteboards cost between £9.00 - £25 dependant on size Pens approx. £1.20 - £1.40 per pack

## Q3 How much does it cost to have a whiteboard installed?

A3 Royal Stoke retained Estate and County Estates charge approximately £25.

Costs from the PFI Contracted service not held by the Trust.

Q4 How much funding is allocated to each ward for fire safety to approve an installation of







#### whiteboards?

A4 Budgets are not allocated in this way. Advice is sought from the Fire Safety Advisor as required; this service is provided by the Fire Safety Team on behalf of the Estates, Facilities and PFI division.

### Q5 What is the stationary budget (to pay for the whiteboard and pen installation) for ward?

A5 This is part of a wider budget and we are unable to split out, therefore, Information not held
