I am writing to acknowledge receipt of your email dated 24th January 2024 requesting information under the Freedom of Information Act (2000) regarding w non-surgical procedures

On 26<sup>th</sup> January 2024 we contacted you via email with the following:

To continue with your request we require clarification on the following:

*Botched non-surgical procedures* is not a medical term, therefore please explain what you are referring to , also are you implying the UHNM has done this or if patients are coming for rectifying treatments?

On the same day you replied via email with:

'Yes, of course.

*I am referring to physical complications following non-surgical cosmetic procedures, such as nodule formation, discolouration, migration and herpetic outbreaks.* 

To answer your second question, I am seeking data on the number of patients coming for rectifying treatments.

I hope this provides some clarity.'

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Under the FOI Act, I would like to request the following information regarding patients seeking treatment for botched non-surgical procedures, such as Botox and filler:

The total number of patients that have been treated at all your hospitals for botched non-surgical procedures for quarter 2 of 2023-2024.
