UHNM has received several requests that are asking for similar information that are from the same person/company, therefore we are contacting you to inform you that under section 12 of the FOI Act we were aggregating these requests on CAMHS and staffing

Your new reference number for BOTH is 681-2324

The section 12 exemption states:

The authority can combine related requests received within a period of 60 consecutive days from:

- The same person or
- People who appear to be acting in concert or in pursuance of a campaign.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- What is the average waiting time for a Neurodevelopmental assessment for children and adults?

- Who is the person responsible for managing this waiting list?
- Has University Hospitals of North Midlands used independent providers to carry out work on the waiting list?
