I am writing to acknowledge receipt of your email dated 12th February 2024 requesting information under the Freedom of Information Act (2000) regarding FMG

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 I would like to request the following information from your Trust acute, mental health, or otherwise.
 - 1. How many patients have come into your care with Female Genital Mutilation (FGM) that was noticed and/or attended to, between January 2014-February 2024 calendar years?

NOTE: Please specify if the data is relating to a physical or mental health concern and please make sure to list the physical and mental health concerns separately.

A1 Unfortunately due to changes in patient record systems we are unable to obtain accurate figures prior to June 2017. FGM was not centrally recorded in a way we can easily extract.

Please note that UHNM is not a mental health Trust, and we have provided all the information new are able to. Section 12 exemption applies for any physical and mental health concernssee below:

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in this question is not held centrally, but may be recorded in health records (for the time period asked for = 254 notes). In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health







records and then extracting relevant information would take longer than the 18 hours allowed for.

In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: oppressive burden on the authority

Where the same patient has presented at our service more than once throughout the report period they have been counted ONLY ONCE – by their first recorded FGM contact date Acute Trust:

We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. <u>Personal information</u>. However as the Trust is committed to openness and transparency we can band the numbers as being <5

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed.

 - 2a) corrective FGM (whatever actions need to be taken to correct or improve the damage caused by FGM)
 - 2b) surgery
 - 2c) procedures (non-surgical)
 - 2d) appointments for mental health counselling, therapy, group therapy etc. This includes mental health Trusts dealing with any form of secondary treatment for FGM as I appreciate acute Trusts would look after primary physical care.

Q3 How many FGM-related deaths has your Trust seen between January 2014- February 2024? Please specify how if FGM was a primary or secondary cause of death.

For each of these 3 questions and the sub-sections, could you provide the data in calendar year and could you split the data by month and year (e.g. January 2014, February 2014).

Please provide all of this data in a machine readable format, ideally CSV and provide answers to each question in a separate tab (in this case 3 tabs).

To stress, my questions require answers covering all ages.

I understand that a public authority has 20 working days to comply with information requests.

I would therefore be grateful if you could provide your response within the statutory time frame. As I have sent this email on the 9th of February, a response by the first week of March at the absolute latest, would be appreciated.







If a response is not received by the statutory limit, I intend to complain to the Information Commissioner and request assistance in this matter. Additionally, if it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under the Section 16 obligations of the Act, as to how I can refine my request.
