I am writing to acknowledge receipt of your email dated 11th December 2023 requesting information under the Freedom of Information Act (2000) regarding FGM

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Please provide the following for the last five years, from Jan 1 2019 until December 31 2023.

Please break each of the following down by year (i.e. January 1 2023-December 31 2023; January 1 2022- December 31 2022, etc), and only include each case once (i.e. not the number of occasions one individual attempts to access services):

How many cases or suspected cases of FGM have been identified?

How many of these cases were identified of children under 18?

Of the cases identified in children under 18, how many cases were referred to the police?

Of all the cases recorded, how many cases were referred to the police?

Of the cases identified, how many individuals requested reconstructive surgery via the NHS? Please include the type of reconstructive surgery.

How many of the people identified as victims of, or likely victims of, FGM were referred to psychological or mental health support services?

How many people were referred to specialist FGM support clinics?
