I am writing to acknowledge receipt of your email dated 18th December 2023 requesting information under the Freedom of Information Act (2000) and regarding pension recycling

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Please could you provide information relating to the following questions.

Pension recycling

- 1. Does the trust offer pension recycling (ie their employer contribution is given as salary) to a) medical staff and b) agenda for change staff, as of 1st December 2023?* If the answer to b) is yes, please could you list the bands of staff this is offered to?
- A1 Application is open to all employees who are employed by the UHNM NHS Trust; have an annual threshold taxable income (taxable income excluding the value of pension contributions) on or over £110,000; and for whom the Trust pays an employer contribution into the NHS Pension Schemes.- see attached guidelines
- Q2 The number of medical staff that receive pension recycling (ie their employer contribution is given as salary), as of 1st December 2023*. Please break this down for each medical staff group.
- A2 See below: We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. - 6. In relation to part 5, please provide this data for 2023-24 and the previous four financial years (IE from 19-20 inclusive).

See attached: **note**: the request states central funding rather than local we believe you're referring to the additional 6.3% pension costs we've had to account for over the last few years. we have looked at the finance journals we have posted over the last few years (going back to 2019/20 as the FOI requests) and included the income value we have entered into the finance positions on the final month of the financial years.

If you are trying to determine the local or total funding for pension costs we confirm that this is not possible for us to extract as this will be part of the block income payment that UHNM receives and cannot be identified/split out.

The question also asks for the current financial years forecast cost or year-to-date costs; this is not obtainable as it is not included within the Trust forecast nor is it accounted for in M01-11. It is a transaction which is only transacted in the final month of the financial year so we cannot report this number until year-end.

UHNM NHS Trust is a public sector body and governed by EU law. FOI requestors should note that any new Trust requirements over the EU threshold will be subject to these regulations and will be advertised for open competition accordingly.
