I am writing to acknowledge receipt of your email dated 11th December 2023 requesting information under the Freedom of Information Act (2000) regarding red flags aggregated with two other requests received at a later date- see below:

On 12<sup>th</sup> January 2024 we contacted you via email with the following:

UHNM has received several requests that are asking for similar information that are from the same person/company, therefore we are contacting you to inform you that under section 12 of the FOI Act we were aggregating these requests on Induction of Labour and red flag

The section 12 exemption states:

The authority can combine related requests received within a period of 60 consecutive days from:

- The same person or
- People who appear to be acting in concert or in pursuance of a campaign.

On 31<sup>st</sup> January 2024 you( same company) sent in another request on sexual assaults , we replied as above with a new reference for all 3 requests as 733-2324 and advised you that the 'clock' re-started for all requests as of 31<sup>st</sup> January 2024
