As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- A4 In the 2022/23 Annual General meeting, it was stated that there were 1,450 beds in the Trust.

It cannot be assumed that all the beds are occupied or that the patients are eating, as this could change due to medical guidance.

The Trust also provides snack boxes for outpatients, Renal, Chemotherapy and any patients waiting in Emergency Department for an inpatient bed.

There may also be extra provision required under "Your next patient" which would also not be factored in for the daily amount ordered.

Apologies that we are unable to provide a definite number of meals provided on a daily basis.
