I am writing to acknowledge receipt of your email dated 2nd February 2024 requesting information under the Freedom of Information Act (2000) regarding Telephony Services..

UHNM has answered this identical request eight times, therefore we are only supplying any relevant updates and advise you to refer to the spread sheet we supplied 13th January 2020 on Reference 444-2021 and our detailed response on reference 146-2021 which covers any and all previous queries you may have had.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I would like to submit a new FOI request.
