I am writing to acknowledge receipt of your email dated 9th January 2024 requesting information under the Freedom of Information Act (2000) and regarding agency.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Please could you answer the below questions in relation to Nursing on framework supply;
 - 1. Please can you confirm how many shifts have been released/allocated to ON framework agencies within the last 90 days?
- A1 3791
- Q2 In the last 90 days which wards, or departments were these ON framework requests for?
- A2 Various wards across all divisions
- Q3 Please can you confirm how many nursing shifts have been filled by ON framework agencies within the last 90 days?
- A3 3105
- Q4 How many long term lines of work or block bookings are currently being supplied by ON framework agencies?
- A4 Unknown as most agency workers book via the agency but work regularly in the Trust so not true block bookings
- Q5 Which ON framework agencies is the Trust currently utilising for Nursing vacancies and what is the spend on these agencies year to date?







- A5 The total spend on Nursing Agency this financial year to date is £6.63m (from 1st April 2023 to 31st January 2024).

 For the current calendar year to date, the total spend on Nursing Agency is £0.65m (covers January 2024 only).
- Q6 Please can you confirm how many shifts have been released/allocated to OFF framework agencies within the last 90 days?
- A6 Nil released via the nurse bank
- Q7 What is the average charge for both RMN's and RGN's from ON framework agencies?
- A7 The average is about £32.00 per hour
- Q8 Who at Temporary Staffing is responsible for onboarding new agencies and could you provide their email address and contact number?
- A8 I can confirm that the Trust holds information regarding this question, but feel this information is exempt under section 21: *information reasonably accessible by other means*.
