## Dear

I am writing in response to your emails dated 17<sup>th</sup> February and 13<sup>th</sup> October 2020 requesting information under the Freedom of Information Act (2000) regarding cost of OVM for *University Hospital of North Staffordshire NHS Trust.* (previous reference 675-1920)

On 17<sup>th</sup> February we contacted you via email as we required clarification on which Trust you required information for, we stated:

As of 31<sup>st</sup> October 2014 University Hospital of North Staffordshire NHS Trust (UHNS) ceased to exist. As of 1<sup>st</sup> November 2014 Royal Stoke University Hospital and County Hospital (Stafford) became known as University Hospitals of North Midlands NHS Trust (UHNM).

On 12<sup>th</sup> October sent a chaser, but this time for the correct Trust, however without a reference number, we advised you via email that in order to investigate you would need to provide this- which you have done so today.

UHNM received this request on 17<sup>th</sup> February 2020 from who we contacted via email on that same day, advising him that he was requesting information from a Trust that no longer existed-see attached, no clarification was forth coming from so this request was closed after 2 months as stated in our email.

As your request was closed your reference number is 284-2021 please quote this number on any correspondence.

Please note that we require a contact name for this request as we now have 2, please confirm who is handling this request.

On 13<sup>th</sup> October 2020 you contacted us via email stating that you would be handling this request and not Mr Walpole.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Does the Trust employ a person, or persons whose job it is to identify people who may be required to pay for NHS care, often referred to as an overseas visitor manager?







- At UHNM currently employ one Overseas and Private Patient Manager and three Overseas and Private Patient Officers as of February 2020, prior to this there was no dedicated Overseas and Private Patients Manager.
- Q2 If yes please provide information about the job title, Agenda for Change pay band, and duties of each role in the team
