I am writing in response to your email dated 16th October 2020 requesting information under the Freedom of Information Act (2000) regarding our response to your request reference 264-2021 covering maternity statistics.

You stated in your email the following:

Hi there - thanks for this - however, unfortunately not all statistics have been broken down per location as I requested and some of the information is more broken down than I need. Could I please ask you to use the table below to provide your response?

We advised you the same day that this was a new request and therefore issued you with a new reference number.

A copy of your original request will be placed on the Trust disclosure log.

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in questions 2, 6 and 7 is not held centrally, but may be recorded in individual health records. In order to confirm whether this information is held we would therefore have to individually access all individual health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all individual health records and then extracting relevant information would take longer than the 18 hours allowed for.







In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority*

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just the questions that we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

A1 We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. *Personal information*. However as the Trust is committed to openness and transparency we can band the numbers as being <5.

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed. Please see below:

For Q2 we are unable to pull accurate figures for induction as this information is partly held in patient free text notes which can't be used for analysis purposes. Actual induction rate may be much higher Q6&7 ladies indicated as PPH of 1500ml+ will also be included in the PPH500 count- section 12 and 14 exemptions as detailed above.

*When asking for Birth type (instrumental etc.) as the count is based on 'delivery' multips will be counted by the first delivery location & / or method.

*Please note that any individuals identified do not give consent for their personal data to be processed for the purposes of direct marketing.

UHNM NHS Trust is a public sector body and governed by EU law. FOI requestors should note that any new Trust requirements over the EU threshold will be subject to these regulations and will be advertised for open competition accordingly.
