I am writing to acknowledge receipt of your email dated 31st October 2022 requesting information under the Freedom of Information Act (2000) regarding overseas recruitment

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 How much has this Trust spent on overseas recruitment (including all recruitment related activities, overseas recruitment trips, agency fees, staff salaries of overseas recruits of all occupations - such as nurses, doctors, admin staff etc. - including costs of relocation, flights etc.) from 1st January 2017 - the present (31st October 2022)?
